STUDENT'S RIGHT TO CANCEL

CANCELING YOUR ENROLLMENT DURING THE FIRST SEVEN DAYS AFTER STARTING CLASS:

1. You have the right to cancel this Contract for a course of instruction including any equipment or other goods and services included in the Contract, within the first seven calendar days following the first day of class. Registration fee is non-refundable.
2. Cancellation shall occur when you give written notice of cancellation at the address of the School shown on the top of the front page of this Contract. You can do this by mail, hand delivery, or email.
3. The written notice of cancellation, if sent by mail, is effective when post marked by a mail office.
4. The written notice of cancellation need not take any particular form, and, however expressed, it is effective if it shows that you no longer wish to be bound by this contract.
5. The student has the right to cancel the enrollment agreement and obtain a refund of charges paid through attendance at the first class session, or the seventh calendar day after enrollment, whichever is later.
6. If the student has received federal student financial aid funds, the student is entitled to a refund of moneys not paid from federal student financial aid programs. The School will refund any money that the student has paid within 45 days after the school receives your notice of cancellation. 7. The institution shall advise each student that a notice of cancellation shall be in writing, and that a withdrawal may be effectuated by the student's written notice or by the student's conduct, including, but not limited to, a student's lack of attendance.
